## Privacy Policy

Privacy is of fundamental importance to CEN and this Privacy Policy outlines how we collect, use, and safeguard your information on our Site. This Privacy Policy applies **only** to information we collect through the Site. If you are accessing the Site for or on behalf of a company or organization, all references to “you” or “your” shall include such company or organization.

### Information We Collect

The information we collect generally falls into four categories: (1) personal information you provide voluntarily, such as when you provide us with your information to register or learn more about CEN; (2) tracking information we may collect as you navigate through the Site; (3) non-personally-identifiable information and statistics collected from surveys, prediction requests or other requests for information that we may make applicable or available to users of the Site; and (4) commercially sensitive information you provide voluntarily on behalf of your company or organization, such as when you provide information regarding finances, expenses and income related to the company generally or its solar projects. In the event that you provide the information described in clause (4), a Non-Disclosure Agreement shall be entered into by you and CEN.

### Personal Information

As part of the registration process, and from time to time, we may ask for your name, mailing address, email address, telephone number and other personal or commercially sensitive information. We use this information to customize your online experience, provide you with personalized email and direct mail messages about CEN and help us improve the Site.

You may give us permission to access certain personal or sensitive information stored by third parties or other services. For example, you may link your Facebook, LinkedIn or Twitter account to the Site, which allows us to obtain information from those accounts. The information we obtain from those accounts, sites or services varies by site and is controlled by your privacy settings on such site. By authorizing CEN to have access to this information, you agree that CEN may collect, store and use such information in accordance with this Privacy Policy.

## Tracking Information/Cookies

When you visit our Site, we may collect tracking information such as your browser type, the type of operating system you use, which pages you visited on our Site, and which search terms you entered. We use cookies, Web beacons, and other technologies for analysis and personalized services.

A cookie is a small text file that is sent to your computer by our Site's server. We use cookies to collect tracking information and to remember information you have given us. This is done so that you don't have to reenter the information each time you visit our Site. Most web browsers can be set to inform you when a cookie has been sent to you and provide you with an opportunity to refuse that cookie or to remove it later. Please note that if you remove or chose not to accept our cookies, you will need to reenter your information and reselect your preferences each time you visit our Site.

## How Your Information Will Be Used and Shared

We will use the information we collect from and about you for various purposes, including for registration and validation purposes, responding to your requests, providing you with additional information about CEN, improving our Site, and customizing your experience on our Site. We may also use the information we collect from and about you to create, distribute certain non-personally-identifiable information and aggregate statistics derived therefrom, as described more fully in Section C below. We value your privacy and will not sell your personal information (name, mailing address, email address, telephone number or credit information, if collected) to third parties. However, we may share your information with third parties under limited circumstances, such as:

- **A. Service Providers.** We may share your information with third-party service providers who help us operate and maintain our Site or deliver our services, storage of personal information. Any third-party service provider with whom we share your information will be contractually restricted from using or disclosing your personal information for any purpose other than as necessary to provide the services for which the information was disclosed.

- **B. For Legal Purposes.** We will release information when we believe we are legally required to do so, such as in response to a court order or subpoena. We may also be required to release information if we are purchasing or selling a business, although in such cases your information would normally be covered by a non-disclosure agreement.

- **C. Aggregate Information.** We may disclose to third parties non-personally-identifiable information and aggregate statistics, such as results from surveys, prediction requests or other requests for information, overall patterns or demographic reports, and information regarding user behavior as a measure of interest in, and use of, our Site and marketing materials. Such disclosures will not describe or identify any individual user.

## Updating or Correcting Your Information

## **Security**

We have put in place appropriate physical, electronic, and managerial procedures to safeguard and help prevent unauthorized access, maintain data security, and correctly use the information we collect. We maintain a secure process to collect, transmit, and store your personal information.

Please note that no method of transmitting or storing electronic data is ever completely secure, so we cannot guarantee that such information will never be accessed, used, or released in a manner that is inconsistent with this Privacy Policy.

If we introduce password-protected features, we urge you to keep any online password we may provide you in a safe place and not to disclose it to anyone. Also remember to sign out and close your browser window when you have finished your visit, especially if you are sharing a computer with someone else or are using a computer in a public place, such as a library or Internet cafe.

## **Minors**

We do not knowingly collect personal information from children under the age of 13 on our Site. If we become aware that we have inadvertently received personal information from a visitor under the age of 13 on our Site, we will delete the information from our records.
